

# CHEMICAL, BIOLOGICAL, & RADIOACTIVE WASTE COLLECTION SCHEDULE – Spring 2018

**Radioactive Waste** - All radioactive waste is disposed by appointment only. For information, packaging instructions, and to request a waste disposal appointment, please visit the Radiation Safety web page at: <http://ehs.iu.edu/topics/radiation-safety/radioactive-materials/index.shtml>.

**Biological Waste** – Most biological waste generated at IUB can be disposed in the regular trash or in the sanitary sewer after proper disinfection or sterilization. Please refer to the Biological Waste Management Guidelines at <http://ehs.iu.edu/docs/Biological-Waste-Disposal-Guide.pdf> to determine the proper disposition of specific waste materials. Biohazardous waste that cannot be disposed in the regular trash after proper disinfection will be picked up or should be brought to an open house according to your campus location following the same procedures as chemical waste (see below for your location). Animal carcasses must be frozen. They are picked up on Tuesday mornings by request (**except Mar 13 and Jul 3**).

**Chemical Waste** - Chemical waste is collected by EHS staff by request for campus locations other than Chemistry and Simon Hall. Requests must be submitted online by the afternoon before the scheduled pickup day to be included on the next day's pickup schedule. An open house collection is held in the basement of Chemistry on Thursday afternoons for occupants of Chemistry and Simon Hall to bring waste for disposal. No appointment is necessary for open house.

**Jordan Hall and Myers Hall** - Chemical waste is collected from labs by EHS staff. Scheduled pickup days are: **Jan 9, 23, Feb 6, 20, Mar 6, 20, Apr 3, 17, May 1, 15, 29, Jun 12, 26, Jul 10, 24, Aug 7, 21, Sep 4, 18**. Waste must be sealed, tagged, and ready for pickup. Supplies will be delivered on scheduled pickup days.

**Chemistry and Simon Hall** - Chemical waste is collected by EHS staff in an "open house" format in CH A027 (in the back of the loading dock area). Scheduled open house collections are: **every Thursday afternoon (except Mar 15) from 2:00-3:30pm in CH A027**. Bring your waste to room A027 during a scheduled collection time. **Do not leave waste with stockroom personnel or unattended on the loading dock!** Waste must be sealed, tagged and dated before being brought for disposal. Safety cans must have working springs in order to be returned to you.

**All Other Campus Locations** - Wastes are collected from your location by EHS staff. Scheduled pickup days are: **every Thursday morning (except Mar 15)**. Special pickup times must be arranged for large quantities of material and for materials that require special handling.

**All waste must be in appropriate, non-leaking, closed containers free from outer contamination. Labels must be clearly legible, securely affixed, and any necessary tags must be properly completed, signed, and dated as required. Solvent waste in safety cans must be compatible with other common organic solvents and have a pH between 3 and 11 when presented for collection.
